NPMC proposes to procure LPG cylinder valves to fit cylinders which are used for the distribution of Liquefied Petroleum Gas (LPG) for the Trinidad & Tobago market.

The supply of 30,000 x 20lb. and 15,000 x 100lb LPG Cylinder Valves according to the required specification to the Trinidad & Tobago National Petroleum Marketing Company Limited (NPMC) for the period 2021/2022.
