

INVITATION TO BID

SEA FREIGHT OF LIQUIFIED PETROLEUM GAS (LPG) TO NPMC'S TERMINAL, CROWN POINT, TOBAGO

Trinidad & Tobago National Petroleum Marketing Company Limited (NPMC) invites suitably qualified Contractors to submit bids for the sea freight of Liquefied Petroleum Gas (LPG) from Phoenix Park Gas Processors Limited (PPGPL) in Point Lisas to NPMC's Terminal at Crown Point, Tobago.

PROJECT SCOPE

Trinidad & Tobago National Petroleum Marketing Company Limited requires the services of a Gas Tanker to transport LPG from PPGPL in Point Lisas to NPMC's Terminal at Crown Point, Tobago.

The project entails:

Sea Freight of Liquefied Petroleum Gas (LPG) from the Phoenix Park Gas Processors Limited (PPGPL) in Point Lisas to NPMC's Terminal at Crown Point, Tobago for the period **2022 May 01 – 2024 April 30**.

Approximately 5,000 – 7,000 barrels of LPG (70/30 propane/butane mix) to be transported to Crown Point Tobago every 6-8 weeks.
