## LFCTT PCS Operator Level 1 (CONTRACT)

The PCS Operator Level 1 monitors and controls the delivery of the fuels through the pipeline system into the storage tanks and then to the loading rack of the fuelling facility ensuring optimal plant performance is achieved with minimal negative impact on the environment.

### **RESPONSIBILITIES INCLUDE:**

- Demonstrate intimate knowledge and understanding of HSE laws, policies and procedures as stated in the company manuals.
- Actively promotes a culture of HSE on the shift/ Company.
- Inculcates strong values and work ethics among the Shift/Team.
- Promotes harmonious work relations and fosters teamwork among other staff.
- Understand and applies plant operating procedures as stated in the standard operating procedures.
- Ensures that the plant is operated in a safe and efficient manner to meet its operational targets as guided by the Standard Operating Procedures.
- Responsible for general housekeeping of assigned area(s).
- Maintains constant communication with the PCS Operator Level 2 and Operations Supervisor directly and/or by radio in field operations.
- Observes local instruments gauges and meters to verify conformance to standard operating practice.
- Locally Start and/or Stop as well as monitor pumps and other equipment based on the direction of the PCS Operator Level 2.
- Perform daily checks and ensure that the plant is operating normally and that no unusual conditions exist.
- Report any anomalies observed to Operations Supervisor and take corrective actions as instructed with assistance of the PCS Operator Level 2.
- Perform manual tank dips as required before and after receiving fuel batch and to verify accuracy of the Tank Gauging System.
- Collect samples as instructed and deliver to laboratory.
- Responsible for safe system isolation before maintenance work as well as remove/return equipment to service after maintenance activities with adherence to Standard Operating Procedures.

- Bleed water from all Jet A-1 tanks as required as per Standard Operating Procedures.
- Assist PCS Operator Level 2 with system line-ups by manipulating all hand and/or motor operated valves.
- Using the tank gauging system, monitors tank levels in Pointe-a-Pierre drawdown tank and Caroni receiving tank.
- Monitors tank levels in Pointe-a-Pierre tanks for upcoming batches.
- Monitors tank levels in Caroni tanks for usage and delivery of fuel.
- Monitors tank levels in Piarco tanks for usage and delivery of fuel.
- Monitors closed drain system and requests and oversees clean-out as required.
- Monitors fire suppression system and assists with monthly inspection reports.
- Assist Road Tank Wagon Drivers with the Accuload System.
- Performs all other duties related to or compatible with the position or as assigned from time to time by the Operations Supervisor in conformance with established HSE policies and procedures.
